I. CALL TO ORDER

The regular meeting of the District Board of Trustees of Broward College was called to order at 1:35 p.m. on Tuesday, April 23, 2024, by Chair Alexis Yarbrough at the Broward College North Campus, 1000 Coconut Creek Boulevard, Building 46, Room 152, Coconut Creek, FL 33066.
